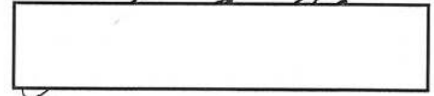

IN REFERENCED AIRTEL, KNOXVILLE REQUESTED EXTENSION OF THE OSJ INVESTIGATION. AFTER CAREFUL REVIEW, FBIHQ HAS DETERMINED THAT INSUFFICIENT JUSTIFICATION EXISTS TO JUSTIFY THE EXTENSION OF THIS INVESTIGATION.

AS A RESULT OF THE EXPIRATION OF THE OSJ INVESTIGATION, THE PATCON GROUP I UCO WAS ALSO TERMINATED ON 7/9/93.

RECEIVING OFFICES SHOULD CONDUCT NO FURTHER INVESTIGATION REGARDING EITHER THE OSJ OR PATCON. KNOXVILLE SHOULD ADVISE ANY AUXILIARY OFFICES NOT IN RECEIPT OF THIS COMMUNICATION OF THE CLOSING OF THE OSJ AND PATCON INVESTIGATIONS.

IF KNOXVILLE SHOULD BECOME AWARE OF INFORMATION INDICATING THAT OSJ MEMBERS ARE INVOLVED IN CRIMINAL ACTIVITY, KNOXVILLE MAY DESIRE TO REINITIATE A PRELIMINARY INQUIRY ON THE GROUP.
