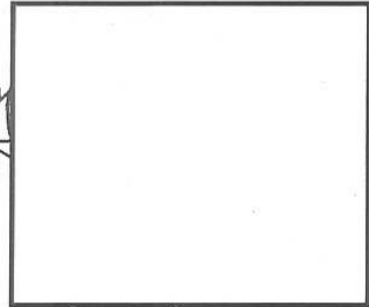

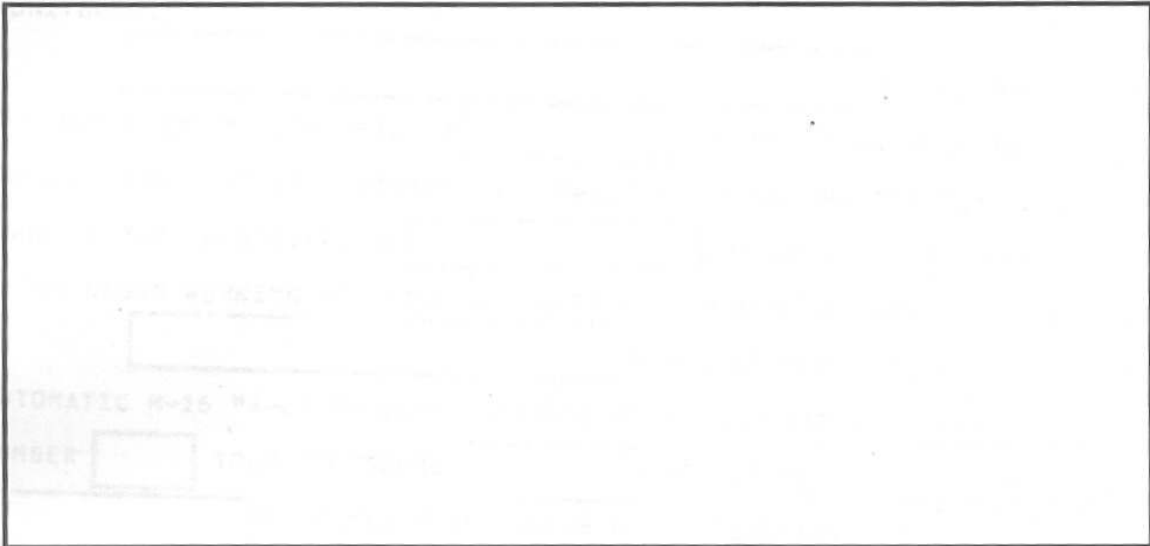

[REDACTED] PAID AN INDIVIDUAL TO GO TO THE FBI IN AUSTIN AS A "PLANT" AND TRY TO FIND OUT WHAT THE FBI KNEW ABOUT CAPTIONED ORGANIZATION BY WAY OF OFFERING MINIMAL INFORMATION IN AN EFFORT TO DETERMINE THE SCOPE OF FBI INFORMATION AND INTEREST. [REDACTED] ADVISED THAT THIS "PLANT" HAD NOT BEEN SUCCESSFUL. FBI AUSTIN HAS RECENTLY HAD A WALK-IN WHO OFFERED TO PROVIDE INFORMATION ON STOLEN GUNS AND WHITE SUPREMACIST ACTIVITY. THIS SUBJECT WILL BE CLOSELY MONITORED.

THROUGH EFFORTS OF THE SOURCE BETWEEN JANUARY 12, 1991 AND JANUARY 15, 1991, TRM MEMBER [REDACTED] WHO CLAIMS TO BE AN EX-U.S. ARMY SPECIAL FORCES OFFICER, HAS BEEN IDENTIFIED AS [REDACTED]

[REDACTED] CONFIRMED TO THE SOURCE THAT SOME MEMBERS OF THE TRM HAD BEEN FIRING A FULLY AUTOMATIC .30 CALIBER WEAPON (NOT FURTHER IDENTIFIED) ON [REDACTED] RANCH ON FRIDAY, JANUARY 11, 1991, AT OR ABOUT THE TIME FULLY AUTOMATIC WEAPONS FIRE WAS HEARD IN THAT SAME AREA BY SSRA [REDACTED]

THE TRM MEMBERS WITH WHOM THE SOURCE MET BELIEVED THAT THE U.S. GOVERNMENT WOULD COLLAPSE IF IRAQ WAS ATTACKED (THEY ALSO THOUGHT THAT THE U.S. GOVERNMENT WOULD COLLAPSE AT THE TIME OF THE INVASION OF PANAMA). THEY FEEL SUCH A GOVERNMENTAL COLLAPSE WOULD ALLOW THEIR GROUP OR GROUPS LIKE IT TO OBTAIN
