

AFFIDAVIT OF LINDA M. SHARP

On this 3<sup>rd</sup> day of April, 2019, Linda M. Sharp appeared before me, an individual known personally to me the person that affixed her signature to this document below and being first duly sworn on this oath, hereby deposes and said:

I, Linda M. Sharp, am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify thereto.

1. My name is Linda Marie Sharp. I have worked as a secretary, administrative assistant, account representative and other positions for numerous businesses from 1982 until 2008.
2. I graduated from Heald Business College in Accounting. I graduated from California State University, Hayward, earning a B.S. in Health Science and minor in Biology. I earned an M.A. in Clinical Psychology from American Schools of Professional Psychology, now operated by Argosy University in Alameda, CA. Both were achieved Magna Cum Laude. In 2008 I was certified as a personal trainer with NSCA (National Strength and Conditioning Association).
3. Targeting of me began much earlier than I originally thought, now that I know what it is, at least since 2008. Although I would have unexplained heart arrhythmia years before 2008 that I now believe was caused by directed energy or remote neural monitoring or whatever the correct terminology is, and in or around 2011, I had unexplained abdominal pains that the doctor couldn't find anything wrong, nor with my heart.
4. Voice-to-Skull, referred to as V2K, began about 2014-2015 that I was aware of. They have said they're "giving me an aneurysm," they are trying to "artificially induce a heart attack," they "clit bomb" and "anal rape" and comment when I defecate. They have made death threats. This is beyond invasion of privacy. It is voyeurism and is illegal as is all the electronic harassment and torture done to me.
5. I became aware of physical electronic torture in 2015 and still continues. The attacks to my head and heart are severe. My eyes and eyesight are damaged by what felt like lasers being shot in them. I needed to get glasses within six months of the first attack on my eyes. In 2016 I had a car accident which I have no memory of at all, or of that entire day and evening. My blood alcohol level was under the legal limit. I suffered a

traumatic brain injury and was hospitalized for sixteen days. It is my belief that V2K and electronic torture played a key role in causing the accident. There have been attacks to my face and body daily and nightly that cause sleep deprivation, screaming and crying. I have pinprick and larger sized burn marks on my body. They "heart hit" while I exercise, causing it to beat extremely hard and fast. They are intentionally destroying heart muscle, my brain and my health. V2K has said this.

6. My cell phone has been hacked numerous times. The camera has been turned on, text messages typed, phone calls missed because it didn't ring yet a voice message notification sounded. My phone was next to me each time this occurred so I know it didn't ring and the ring volume was fine. My computer has also been hacked. The cursor moved, web pages crashed, documents stolen and known passwords repeated via V2K.
7. Gang stalking has occurred. When many people around me resemble so many people that I know or knew this is not a coincidence. Also, V2K have said the names of the person I supposedly knew. Vehicles that drive by that are the same color, makes and models of people I know or knew is also not a coincidence.
8. On March 9, 2019, my furnace turned on yet the power switch was off because I haven't used it in over two years as it needs to be replaced and I use a space heater. I had my neighbor (whose initials are G. L.) verify that the power switch on the thermostat was off while he could hear the furnace running. He disconnected a wire on the furnace to disable it.
9. Numerous times I have contacted Representative Jared Huffman, Senators D. Feinstein and K. Harris. I have mailed letters to DCCC, Nancy Pelosi and Tom Perez. I have also contacted State Senator Kevin De Leon. I have copies of letters mailed and phone calls made.
10. I haven't been hired full-time since 2008. I worked part-time for one month in 2010 or 2011. I was made homeless. During these years my family provided very little, if any, assistance. Because of the trauma, anxiety and loss I've experienced in my life and then highly intensified due to targeting, I filed for disability in 2012 and started receiving I in 2013.
11. I am not suicidal. I have maintained a healthy lifestyle through exercise and good nutrition and normal body weight my entire adult life.
